A student progresses through a series of three benchmarks, called Decision Points, that ensure they meet the expectations of their program and our Indiana Department of Education. Decision Point 1 (DP1) is the first level, followed by Decision Point 2, and finally Decision Point 3. Each decision point has a clinical experience that is supervised by the university. DP1 clinical experiences are characterized by initial exposure to the classroom and short term/ small group instructional experiences. These are generally experiences that are completed over the course of an entire semester. University faculty and staff provide an orientation for the student prior to the experience(s) as well as observations of the student during these experiences. Upon completion of DP1, students are now official teacher candidates of the program and enter DP2. DP2 provides for a more structured practicum experience for teacher candidates. During this stage they prepare, plan, and deliver instruction to p-12 learners in the form of full lessons and short units, in unique field placements that span an entire semester in a variety of combinations. DP3 is highlighted by the candidate's student teaching experience. Supervising faculty oversee the appropriate coursework and physically visit P12 classrooms six times during the semester (more if necessary). During the 2021-22 year, schools welcomed teacher preparation back into their buildings, but continued supervisor adjustments were necessary due to COVID-19 and school building access. This mainly took place in the implementation in a combination of onsite visits and virtual observations using WebEx or GoReact Conference. However, like the previous academic year upon the start of COVID-19, the frequency, duration, and support of our candidates did not decline. Of those six interactions, four are considered formal visits in which the University Supervisor completes an InTASC- aligned EPP-wide assessment. The p-12 classroom teachers selected to mentor our students also complete an InTASC- aligned assessment that parallels the assessment instrument of the university supervisor. These two assessments document and reflect the clinical experience of our candidates and are used as primary source documents when helping determine the overall grade in the student teaching course. Common assessments within clinical experiences are implemented throughout each Decision Point for all teacher candidates, regardless of program in 2021-22. They include a disposition, instruction, assessment, and planning evaluation, in addition to course grades. Individual majors may have entered more specific content assessments under certain Decision Points to assess their students' knowledge, but such specific assignments only pertain to the individual major and, as such, are not EPP-wide. Aligned to InTASC standards and Indiana Teacher Standards (REPA III), all the assessments in our Unit Assessment System (UAS) help measure success in a student's coursework and clinical experiences, but as well as their overall ability to meet InTASC. These assessments are completed by the university faculty assigned to the course. Selecting classrooms in which teacher candidates will be able to observe appropriate dispositions and effectively translate those dispositions into developmentally appropriate learning strategies that positively impact student learning is a difficult task. Considering teacher performance evaluation levels, seeking input from building level administrators, weighing faculty input, and surveying interest of the p-12 classroom teacher in serving in this capacity are all factors in successfully determining appropriate placements for field experiences. This process begins with a signed contract by the classroom teacher, building principal, and appropriate district official. This contract specifically asks the principal to acknowledge and confirm their teacher's ability to have a mentoring mindset. This is very important and different from being an effective instructor in the classroom. We make a distinction between being an effective teacher and being an effective mentor teacher. A different set of skills is required to mentor a, pre-service teacher candidate and gathering interest and dispositions of the prospective mentor is the first step in eliminating those who do not wish to engage or don't demonstrate the skills necessary for successful mentoring. After considering the results of the mentor teacher application, each viable p-12 educator is reviewed for years of teaching experience, educator license status, results of their most recent teacher evaluation, and a recommendation from their building principal is requested. If all five conditions are met, then that individual is approved to take a future student teacher. All five conditions are recorded in our EPP database Tk20 and used for future collaborations. Implementation of this process was and is still pursued at DP1 and DP2 within the

2018-19 – 2021-22 academic years, with a project finish in the 2022-23 year. An effective and qualified teacher is vital to a successful clinical experience and the same is true for university supervising faculty. Under the leadership of Ball State's Professional Education Faculty, policy dictates that anyone teaching a course with a clinical component must have held licensure. Ensuring that concepts taught within courses have an instructional leader capable of guiding student toward practical implementation of those concepts in current classrooms is vital. A faculty committee that governs teacher preparation updates its Professional Education Faculty list each year to ensure it is held accountable, and our students are receiving effective and quality instruction from a formerly/currently licensed teacher.

The accreditation and assessment coordinator worked with all programs in 2020 to align courses required by all candidates in their program to InTASC Standards related to technology. Use of technology is embedded in methods and field experience courses throughout the preparation program. During the student teaching experience, edTPA is required. The program provides significant technology support to the candidates to facilitate this learning. The program adopted a set of modules that meet both InTASC and ISTE Standards. The program was piloted in the fall of 2021 and went live in the spring of 2022. All content areas within the initial preparation program require candidates to complete a module for each ISTE Standard in the program.

Teacher Training

1. Provide a description of the activities that prepare general education teachers to:

a. Teach students with disabilities effectively

Students enrolled in the Ball State’s Elementary Education initial licensure program are prepared to teach students with disabilities throughout several courses and practicum experiences in elementary schools. Begun prior to candidacy, students in EDEL200 – Planning for the Elementary and Early Childhood Classroom learn to identify learning differences and the implications they have on planning for instruction. Students engage in focused observations at the university’s laboratory school, write activity plans to meet the needs of the students in their classroom placement, and reflect on their effectiveness. In SPCE 302 – Teaching Students with Disabilities in the General Education Classroom, a required course for all students in the program, candidates are introduced to concepts, fundamentals, and effective teaching methods for special education. Specifically, they engage in readings and activities (discussion boards, course mini-lectures, situational learning, and projects) related to legal foundations, collaboration, teaching strategies, case conference committees, assessment, and accommodations for the diverse needs of special education students in general education settings. Several specific activities that serve to prepare candidates to effectively teach students with disabilities include: · Professional Learning Community (PLC) Presentation – Candidates are assigned a disability category from IDEA and research and present definitions and characteristics of the disability, resources for teachers, and appropriate and effective inclusive teaching practices. · Universal Design for Learning (UDL) Lesson Plan Revision Project – Candidates examine an existing lesson plan (their own or a found plan) and revise to incorporate key principles of UDL to support all students, including those with disabilities. In EDEL/EDRD300 and EDEL/EDRD350, candidates continue to build on this knowledge and understanding and apply it to practicum experiences as they plan, teach, and assess all students. Throughout this series of courses, candidates develop and modify a conceptual framework that includes their understanding of effective instruction for students with disabilities. Additionally, they apply this developing understanding as they assess students’ needs, plan effective instruction to meet those needs, and reflect on instructional next steps for their students. In EDRD 430, candidates work one-on-one or in a small group with struggling readers. They administer a variety of literacy assessments, analyze and interpret the results, and plan and implement an appropriate instructional program based on the students’ needs. Finally, during the student teaching experience, candidates plan and implement effective instruction for students with disabilities who may be in their classroom. They must demonstrate proficiency in doing so as they complete edTPA which requires them to identify specific learner needs of students with IEPs and plan and implement appropriate and effective instructional modifications and accommodations for these students.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

As described previously, candidates enrolled in SPCE 302 – Teaching Students with Disabilities in the General Education Classroom engage in readings, discussions, and lectures related to case conference committees. During the PLC presentation described above, candidates learn about and present resources and effective inclusive teaching practices to their peers much like they will do as a member of an IEP team. Additionally, during EDRD430, candidates present their “case studies” of their focus student with whom they work to their peers and discuss instructional options. During the student teaching semester, candidates have the opportunity to participate in actual IEP team meetings with their mentor teachers (as appropriate) to gain additional experience.

c. Effectively teach students who are limited English proficient.

Throughout the program, students learn about the principles of effective instruction of linguistically diverse students and apply these as they plan and implement instruction. Prior to candidacy, EDEL244 -Early & Elementary Education for Social Justice, students examine their attitudes towards others from linguistic backgrounds other than their own and develop knowledge of recent literature and research regarding teaching linguistically diverse students. Throughout each literacy methods course (EDRD 204, EDRD 300, EDRD350, and EDRD430), candidates read about, discuss, and implement specific strategies for supporting linguistically diverse students in reading, writing, listening, speaking, viewing, and visually representing.

Several of our immersive learning opportunities, including Schools within the Context of Community and the Urban semester, take place in schools with a high degree of language diversity. During practicums and student teaching, candidates may have the opportunity to apply these as they plan and teach English learners. When completing edTPA, a program requirement during student teaching, candidates must focus their planning, instruction, and assessment specifically on the language demands of the selected literacy strategy.

a. Teach students with disabilities effectively

Evidence-based practices in the graduate and undergraduate methods courses include Direct Instruction, explicit instruction and remedial strategies in literacy instruction, supporting student learning using graphic organizers, learning strategies and organizational skills. Opportunities for application occurs in the advanced practicum, taken concurrently with the undergraduate methods course. Writing lesson plans and unit plans with specific learning needs in mind is a major focus at the undergraduate level.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

A 5-week IEP unit in SPCE 376, Methods in Mild Interventions K-6, focuses on all components of IEPs as well as the IEP process/case conference committee and eligibility determination. The emphasis is on writing Present Level of Academic Achievement and Functional Performance, annual goals, and accommodations. Using a case study, students write an IEP in groups of four. In the graduate mild interventions methods course, SPCE 688, a book on writing IEPs is one of two required textbooks. Based on a case study, candidates write components of an IEP and respond to in-depth focus questions targeting IEP procedures and components.

c. Effectively teach students who are limited English proficient.

Throughout the program, candidates are required to consider and plan for the specific needs of EL learners when developing lesson plans, selecting and conducting assessments, and reflecting on their teaching. In the undergraduate program, Culturally Responsive Teaching and Sheltered Instruction (IRIS Module) are included in the course material. Candidates in SPCE 376 have to complete an assignment based on the IRIS Module, Teaching English Language Learners: Effective Instructional Practices, as well as a differentiated instruction lesson that includes specific accommodations to address the needs of EL learners. In SPCE 375, Candidates must evaluate assessments for cultural and linguistic bias and develop assessment plans that consider the specific needs of students who are limited English proficient. At the graduate level, SPCE 686 (Introduction to Mild Disabilities) includes assigned readings and reflections on student differences, including cultural and language differences. In SPCE 687, Candidates must evaluate assessments for cultural and linguistic bias and develop assessment plans consider the specific needs of students who are limited English proficient. Candidates in the methods course, SPCE 688, develop and teach a differentiated instruction lesson. After teaching the lesson, they reflect on the process, including the impact of student differences (e.g., cultural, linguistic) on learning.

At the March 11, 2015, meeting of the Professional Education Committee (PEC), members passed a motion to change the policy that candidates successfully pass the Indiana CORE Assessment (licensing exams) in order to complete BSU's teacher preparation program. The previous policy indicated that candidates could not complete the teacher education program or earn a degree in an education related field unless they passed all exams--they could request a BA in General Studies. The new policy indicates that candidates may complete a teacher preparation program and earn a degree in an education related field without either taking or passing the Indiana CORE Assessments--they just can't apply for Indiana licensure until they pass all licensing exams. In addition, the recommended policy change called for candidates who had failed licensure exams as far as three years prior to petition to receive an education degree. Under Title II reports prior to this change, the institution's pass rate was always 98% or higher, because passage of the test (Praxis II prior to Pearson's Indiana CORE Assessment) was a requirement for program completion (a small handful of candidates were given waivers by the state; otherwise, the passage rate would have been 100%). Because of this new policy, our passage rate will be lower than 100% because a person can complete a program now without successful completion of the test. The Indiana General Assembly eliminated basic skills testing as a requirement, effective July 1, 2019. Ball State University became test optional at the beginning of the 2019-2020 academic year. Ball State University changed the minimum GPA requirement to 2.5 in the spring of 2019. Under Special Education, BSU offers the following licensing areas: Deaf and Hard of Hearing Special Education: Mild Intervention Special Education: Intense Intervention Special Education: Dual Major (ELED/SPCED) Special Education: Dual Major (Early CHD/Early CHD SPCED) Special Education: Early Childhood Special Education. Under Social Studies, BSU offers the following licensing areas: Historical Perspectives Government Psychology Sociology Economics Geographical Perspectives All candidates must select Historical Perspectives. Typically, candidates in the program select three of the above areas. In Music Education, candidates may select either Choral Music or Instrumental Music. Health and Physical Education is a combined program. On September 1, 2021, The State of Indiana moved from a Pearson state to a Praxis state for the required licensure content and pedagogical exams.
